


Post-construction processes

The building warrant of fitness

Building Act 2004 Section 108 2)


"The purpose of the building warrant of fitness is to ensure that the specified systems listed on the compliance schedule are performing and will continue to perform to the performance standards laid out in the relevant building consent"

- Sometimes referred to as the "Cumulative Effect"







What happens when problems are found?

- "...but the council signed it off..."
- Failure to issue the BWOF
- Potential fines
- Affects insurance, finance, licenses
- Risk to ongoing tenancy agreements
- Costs of remedial action







Accountability

- Producer Statements are binding
- Legal liability
- Civil action to recover costs for repair and trading losses
- This requires time and money








- Building Constructed 2014-2015
- Ground floor retail
- First Floor car parking
- 4 floors of offices @~750m2 each
- Code Compliance issued April 2015
- 6 BWOFs issued
- New owner 2021 undertakes due diligence
- Incoming IQP finds myriad of issues






















- Building owner evaluates repairs at \$500k
- Investigates legal action against:
 - Developer / Previous owner
 - Constructor (PS3)
 - Fire Engineer (PS4)
 - Council (Code Compliance)
 - Previous IQP (12A)
- Decides that legal action will take too long (impacting the BWOF, security of tenancies) and be too costly with some risk of failure. Funds repairs themselves.
- No accountability on those at fault.










Design

- The "Perfect World".
- Lack of trade coordination.
- The design may be impractical to implement for some trades.
- This leads to necessary innovation on site.
- Unplanned alterations can lead to oversight.





Construction

- Lack of qualified staff
- Staff Training
- Oversight and supervision
- Cost pressures
- Tendering finds the lowest common denominator
- Cheap gets the job










Construction Monitoring





- Evolution of the site works means necessity to be on site regularly.
- Designers are not always installation experts.
- Site inspections don't see every aspect.
- Actual construction may not fit the textbook solution.
- The engineer who creates problems doesn't get the next job.









The solutions

- Having fewer holes, not more slices of cheese.
- Improve the quality of the process, don't just add more flawed processes.
- Have certification of more contractors in life safety trades.
- Improve qualifications and make these requirements to operate.
- Have these trades accountable for errors.











The solutions

- Create a process to deal with complaints and hold trades to account.
- Discourage shady contractors through accountability.
- Ensure regular recertification processes exist.
- Assist victims to seek compensation and justice in a timely manner.

















